LETTER FROM BUCK STINSON

While there is increasing awareness of long term care issues, and public policy in support of long term care planning continues to evolve, too many Americans are still unprepared. The fact is, long term care doesn't become a real issue for most of us until it hits home.

We commissioned our first annual cost of care study in 2001. Since then, the study has received extensive recognition and earned an industry-wide reputation for reliability. It is the resource financial professionals and consumers turn to when planning for long term care needs.

This year we contacted more than 9,000 nursing homes, assisted living facilities and home care providers, with some significant conclusions. While rising costs on facilities have slowed, escalating home care costs outpaced the rate of inflation. The different types of home health aids surveyed in our study show costs increasing to an average of \$25.32 an hour—a 13% increase over 2005 costs. The cost of care study shows what costs are, by type of care and region, so you can plan to live better, not just longer.

Our people helped pioneer the development of long term care insurance over thirty years ago and we take our industry-leading role seriously. When company data revealed that nearly 40 percent of our claimants receive care for Alzheimer's, we decided to partner with the Alzheimer's Association to help raise public awareness about the disease. We are committed to helping individuals make difficult long term care planning decisions. That is why, for the past five years, we have conducted and published the results of our study. Our experience is our strength—you can use it to prepare for the future.

EXECUTIVE SUMMARY

Genworth Financial's current cost of care survey is based on information gathered by CareScout in January and February 2006. Telephone interviews were conducted in 88 separate U.S. regions, encompassing more than 9,000 nursing homes, assisted living facilities and home care providers.

Nursing Homes: Medicare certified nursing homes were surveyed to determine private pay rates for private and semi-private rooms.

- Nationally, the average annual cost for a private room (single occupant) is \$70,912 (\$194.28/day), reflecting a 2.2% increase over 2005 rates (\$190.20/day).
- Nationally, the average annual private room rate at a nursing home increased by \$1,490 (\$4.08/day), compared to the 2005 survey.
- Alaska continues to have the highest average annual cost, at \$191,140, for a private room, followed by New York City at \$140,708.
- Louisiana and Missouri (excluding St. Louis and Kansas City) had the lowest average annual costs for a private room, at \$42,304 and \$43,249, respectively.
- The average annual cost for a semi-private room (double occupancy) is \$62,532 (\$171.32/day), a 2.3% increase over 2005 rates (\$167.44/day).
- Researchers also found that, on average, the cost of care for a private nursing home room in America's urban areas was 17% greater than in non-urban areas. The greatest disparity exists in New York City, where the cost of care was 68% greater than the cost of care in New York's non-urban areas. The cost of care in San Francisco is 45% greater than the cost of care in California's non-urban regions.

Assisted Living Facilities: Assisted living facilities (ALFs) were surveyed to determine the rates for private one-bedroom units. All ALFs surveyed were licensed by the state as assisted living facilities or other comparable residential care facilities.

- Nationally, the average monthly cost for a private one-bedroom unit is \$2,691.20 (implying a daily rate of \$88.48/day), reflecting an average annual cost of \$32,294.40 – a 6.7% increase over 2005 survey rates (\$30,265/yr.). These rates exclude any one-time community or entrance fees.
- Nationally, the average one-bedroom rate increased \$2,029 per year (\$169/mo.) compared with Genworth's 2005 survey.
- The highest annual costs for one-bedroom units in ALFs is the Bridgeport area of Connecticut (\$57,566.52 excluding community fees) and the state of New Jersey, excluding the Newark and Edison areas, (\$51,314.41 excluding community fees).
- North Dakota (\$20,714 excluding community fees) and Arkansas (\$20,937 excluding community fees) have the lowest annual cost for a one-bedroom unit in an ALF.
- Approximately 33% of the ALFs surveyed charge a one-time fee, commonly referred to as a community or entrance fee, ranging from \$50 to \$8,490 with a national average one-time fee of \$1,369.68.

Home Care: Home care providers were classified into three types, according to certification and licensure status. The three provider types are:

- Medicare certified home care providers. These providers are also licensed.
- Non-certified but licensed home care providers.
- Non-certified and non-licensed home care providers.

Researchers surveyed all three home health provider types to determine the hourly charge for care provided by certified Home Health Aides. Also, the two types of non-certified providers were surveyed to determine the hourly charge to provide homemaker services.

- Across all home care provider types, the average hourly rate for home health aides is \$25.32, a 13% increase over 2005 survey results. The average hourly rate for homemaker services is \$17.09, a 3% increase over 2005 survey results.
- Certified home care providers charge the most for home health aides, averaging \$36.22 per hour (a 17% increase over 2005), compared to \$22.15 per hour charged by non-certified but licensed providers (a 19% increase over 2005), and \$17.57 per hour charged by non-certified and unlicensed providers (flat compared to 2005).
- Unlike certified home care providers, the non-certified providers also offer homemaker services. Nationally, non-certified but licensed providers charge \$17.73 per hour (a 5% increase compared with 2005 survey results), while non-certified and unlicensed providers charge \$16.45 per hour (flat compared to 2005).



METHODOLOGY

CareScout, based in Wellesley, Massachusetts, specializes in eldercare provider databases and helps families select appropriate providers nationwide. CareScout conducted the survey for Genworth Financial, contacting over 25,000 providers and completing over 9,000 surveys during January and February 2006. Those surveyed include nursing homes, assisted living facilities and home care providers in all 50 states and the District of Columbia.

Genworth's study is the most comprehensive and in-depth survey of its kind. In addition to nursing homes, the Genworth survey includes assisted living facilities and three types of home care providers (Medicare certified providers, non-

certified but licensed providers, and non-certified and non-licensed providers).

Regional designations are given to provide more accurate estimates in areas where there are large variations in costs. For example, Philadelphia and surrounding counties are separated from the rest of Pennsylvania because care is markedly more expensive in that region than in the rest of the state. This method yields more meaningful figures than providing a single average rate for every state.

Nursing Homes: Researchers conducted telephone interviews among a sampling of nursing homes across the 50 states and the District of Columbia, based on counties.

Within the 88 designated regions, researchers polled a minimum of 15 percent of all certified and licensed nursing homes. In no region did less than 10 providers complete the survey, and in many areas the sample size was significantly larger. More than 2,300 providers completed the survey.

The survey evaluated the cost of care for a private room (single occupant) and a semi-private room (two occupants) in Medicare certified nursing facilities. Medicare certified nursing homes represent more than 95% of all nursing homes in the U.S. Rates for transitional care units (typically hospital based) were not included. The daily room charge usually includes services beyond room and board, such as three meals a day, laundry, sundries, basic nurse supervision and generic brand, non-prescription pharmaceuticals.

Assisted Living Facilities: Within the 88 regions surveyed, researchers polled approximately 10 percent of the licensed facilities. In no region did less than 10 facilities complete the survey, and in many areas the sample size was significantly larger. More than 3,300 providers completed the survey.

Unlike nursing homes, there is no national, uniform regulatory protocol for assisted living facilities. As a consequence, the licensing standards vary from state to state. CareScout researchers interviewed assisted living facilities licensed according to the requirements of the state in which the assisted living facility was located.

The survey evaluated the monthly rent for a private, one-bedroom unit in an assisted living facility. Researchers also procured community/entrance fee data. Community and entrance fee rates are not included in the average monthly assisted living rate data tables.

The monthly rate usually includes three meals per day and sometimes includes basic care-related supervision. It typically does not include additional costs for care such as therapy, rehabilitation or medication costs.

Home Care: Researchers conducted telephone interviews among a sampling of home care providers across the 88 regions, polling a minimum of 10 percent of the home care providers per region. In many areas the sample size was significantly larger. Over 3,300 providers completed the survey. All rates are weekday (Monday – Friday) rates.

Three types of home care providers were surveyed. The three types are:

1. Medicare certified and licensed home care providers
2. Non-certified but licensed home care providers
3. Non-certified and non-licensed home care providers

Researchers surveyed all three home health provider types to determine hourly charges to provide care by certified Home Health Aides. Home Health Aides provide personal care but not medical care. For example, a Home Health Aide typically helps with bathing, dressing, transferring and toileting, but not with catheters or injections.

Researchers also surveyed the two types of non-certified providers to determine hourly charges to provide homemaker services. Homemakers generally do not provide hands-on care; their services usually include help with shopping, finances, cooking, running errands, transportation and/or providing companionship.
